



4th Annual Juried Art Show -- Landmarking Historic 89A

Walkin' on Main – A Celebration of Historic 89A and Arizona's Centennial

Juried Art Show held at the Walkin on Main Festival: November 12, 2011 from 11am - 5 pm.

Eligibility: Seeking traditional and contemporary artwork reflecting images on, near or inspired by Historic State Route 89A in Arizona. The following media are eligible: oil, acrylic, water, pastel, mixed-media, photography and printmaking. Traditional and digital photographs are accepted with a strong emphasis on non-digitally-manipulated photography. For questions regarding eligible media that are not addressed here, please e-mail walkinonmain@gmail.com. Work should have been completed in the last four years. Artists must be at least 18 years old.

Entry Fee: \$30 for five images. Additional images \$10.00 per image. Check or money order accepted: make check payable to **City of Cottonwood**. Entry fee non-refundable

Award: Jury will select one work to receive \$350 and will also choose the works to be included in the 4th Annual Juried Art Show - Landmarking Historic 89A as part of the Walkin' on Main festival. At the option of selected artists, the festival art show will be followed by a discretionary Fall 2011 Exhibition at Manheim Gallery and Maison Art and Antiques in Old Town Cottonwood from November 19th – December 30th. Fall 2011 Exhibition selections are at the discretion of the jury and respective galleries -- and at the option of those artists selected.

Entry Instructions: Jury will review from digital images only. Minimum of three images per artist. Additional images beyond five will be considered for \$10.00 each image. Submit Jpeg files on CD only. Files should be at least 150dpi and no larger than 1000 pixels in the longest dimension. Title each image file with your first and last name, then the image number and the title of the piece, which should correspond to the submission form (example: JaneDoe_001_Title, JaneDoe_002_Title,...). Submission forms must be typed. Images on CD must accurately represent the work being submitted. Walkin on Main Art Exhibition Committee retains the right to reject any work that is not accurately represented by the CD. CDs will not be returned.

Deadline for Submissions: October 20th, 2011

Notification of acceptance will be sent on **October 27th, 2011**

Framed art must arrive at the gallery no later than 5pm on **November 8th, 2011**



Art Show Requirements: Work selected for the Art Show must be framed, mounted and fitted with wire and ready for hanging. Frames must be metal or wood. Works on canvas must be stretched, fitted with hanging wire, and ready for hanging. Exterior frame and glazing are optional. Please note: unframed and unglazed works are more vulnerable and the committee does not accept any responsibility for loss or damage.

AGREEMENT: Accepted work may not be withdrawn before the close of the exhibition and must be displayed for the entire November 12, 2011 event. The exhibition committee reserves the right to reject any work that does not meet the criteria set forth in this call for entries and reserves the right to remove work that does not reflect that which was submitted and selected. Only artists displaying their own original work will be eligible to participate. Original works, limited edition prints and giclees only. Artists are solely responsible for copyrighting their own work. Submitted work need not be for sale but is encouraged. Those selected artists choosing to display work for sale are entirely responsible for collecting their own payment and paying all applicable taxes. Artists are responsible for the transportation, installation, insurance, and security of their work. **Walkin' on Main, its organizers, sponsors, volunteers and affiliates accept no responsibility for loss/accidents/injury/damages.** Walkin' on Main and its organizers retain the right to use submitted images or photographic images of visual and performing artists, and/or their work, for advertising and promotion purposes in various media. Walkin' on Main and its organizers reserve the right to refuse registration or display to anyone for any reason. All decisions regarding artwork and display for the 4th Annual Juried Art Show – Landmarking Historic 89A are made at the discretion of the Walkin' on Main exhibition committee. All decisions regarding artwork and display for the Fall 2011 Exhibition at sponsoring Old Town Galleries will be made at the discretion of the jury, the respective galleries – and at the option of the selected artists.

Submission of an entry to this exhibition indicates an agreement on the part of the artist with the conditions set forth in this call for artists.
